Selection of an agency for the Design and Execution of a Dance competition to select the participants for Republic Day Parade 2022.

General Information For The Desirous Tender/Bidders For The Aforesaid Project.

Consequent to a Pre - Bid virtual conference held on 04.10.2021 at 11:30 am to answer the general queries and certain doubts in the minds of the tenderers, It was informed to them during the conference to send their queries by mail to Director, NCZCC for its clarification. In response, Director has received about 12 queries which were suitably and promptly answered to the Bidders. A brief note of the same in tabular form has been prepared and is here-by circulated through email for General Information of all and is uploaded on NCZCC official website.

1.	Can the last date i.e. 15.10.2021 can be extended for 7-10-15 days in view of Dussehra festival. And to prepare the Tender properly	The last date cannot be extended for 7-10 days. However in view of Dussehra festival on 15.10.2021 the last date has been extended till 16.10.2021 (6:00 p.m.)
2.	If the single billing condition / binding of Rs 4 Crores for the events related to Central / State Govt's /P.S.U's may be relaxed.	The criteria of 4 crores of a single complete project of Central State Govt./ P.S.U's cannot be relaxed to fall into the eligibility criteria for any bidder.
3.	Can the private or corporate sector's completed project of Rs 4 Crores make the bidders eligible for this project ?	No, Only completed projects of Rs 4 Crore of Central / State Govt. / P.S.U's will fulfil the eligibility criteria.
4.	Can the tender fees / bid documents etc. may be submitted in NCZCC at Delhi.	Yes, The tender fee & documents can be submitted in N.C.Z.C.C. Office at Middle Wing, 3 rd Floor, Janpath Bhawan, Janpath, New Delhi. Till 16.10.2021

5.	Who will decide the (a) Panel of judges , their number & fee. (b) The agency will have to make stay arrangements of the judges ? (c) Will the same judges act at state level / Zonal level / National level ?	(a) M.O.C / NCZCC (b) Yes out of the funds released to it by NCZCC. (c) Different set of judges will act at State / Zonal and National level judges will be State level / National level awarded and rewarded ones.
6.	The District level selection will be physical or digital ?	District level selection will be digital.
7.	How many artists / participants will be selected for the national level.	Finally, 16 groups consisting of 30 artists in each group and this 480 artists will finally performing in the Republic Day Parade. Additionally there will be 2 groups of 60 artists as stand by group for eventually.
8.	Will the state level competition be held at State Capital ?	The state level competition may be held in State Capital or any other big metro city to be decided later by NCZCC / M.O.C.
9.	Do we need to conduct district / state and zonal level competition simultaneously across the country ?	Please see event detail under the head “Project Background” in the notice inviting tender. You will see the competition at various level will be held under different time frames. Location start dates and end dates are already mentioned therein.
10.	Promotion plan - Will it be suggested by NCZCC or agency need to propose the plan ?	The promotion plan will be worked out by the selected agency. NCZCC will not prepare and suggest promotion plan.
11.	How many States and how many Districts to be covered under competition ?	As already mentioned in the Project Background, all districts and all state across the Country are to be cover under the competition.
12.	Travel, Lodging and Boarding of participants – How many participants to be called for State and Zonal level competition respectively ?	The total no. of artists for Republic Day Parade 2022 will be 540 and their selection will be made through all these levels i.e. District ,State ,Zone and

		National. As such at present NCZCC cannot inform the exact no. of total artists to be called for State level / Zonal level competition .But in any case, the selected agency will have to make proper and reasonable travel, boarding and lodging arrangements for all such anticipated artist appearing into the competition out of the funds allocated in the tender.
13.	How many judges will be there ? Who will finalize judges ? Will there be different judges in each state / zone ?	<p>The panel of Judges i.e. their names and numbers will be worked out soon by MOC / NCZCC and the selected agency in due course.</p> <p>The jury members will be different at different levels i.e State level / Inter State level / Zonal level / Inter Zonal level. Their fee will be decided and informed later to the selected agency. The Judges at the National level will be awarded and renowned ones.</p>
14.	Is there any suggested remuneration for judges ?	The remuneration for judges (Jury members) is being worked out at the level of MOC/NCZCC. And will be informed soon to the selected agency. At present it is not available with NCZCC .
15.	Will NCZCC officials also travel in connection with the competition ? if please confirm agency need to arrange for their logistic ?	NCZCC officials will travel during the selection process to various places of Competition. But it will not be frequent and will be limited to essential journeys. As such, for their travels, the Agency will have to make appropriate logistics arrangements out of funds allocated under the tender provisions.
16.	Will there be any prize money for winners of competition ? Will there be any gratification for other participants as well ?	There will be neither any prize money for winners of the Competition nor any gratification for other participants of the selection process.
